
The Investment Committee of the Presbyterian Church Camp and Conference Association is pleased to introduce the Hostetter Fund.

Just as the life and service of Don Hostetter touched the ministries of so many of the camps and conference centers in our denomination, PCCCA seeks to aid these sites by providing financial support to the systems that sustain Presbyterian camp and conference ministry. PCCCA intends to undertake a \$3.3 million capital campaign in order to raise funds for the support of Presbyterian Church (USA) camp and conference ministries. The Hostetter Fund would be structured as follows:

- \$600,000 for a temporarily restricted fund for the support of PCCCA. The proceeds of which will support PCCCA programs and our Executive Director position. The anticipated yearly revenue from this part of the fund will be \$30,000.
- \$200,000 for a temporarily restricted fund held by PCCCA for the support of the Consultants Network. The proceeds of which will support the visits and events provided by the Consultants Network. The anticipated yearly revenue from this part of the fund will be \$10,000.
- \$2,500,000 for a permanently restricted endowment fund held at the Presbyterian Foundation. The proceeds of which will support all or a part of a national staff position for camp and conference ministries housed at our denomination's center in Louisville. The anticipated yearly revenue from the Hostetter Fund will be \$125,000.

We are pleased to report that payments and pledges have been received for each of these purposes which total \$1,133,000 towards our goal of \$3,300,000. These totals are as follows:

<u>National Position</u>	<u>PCCCA Support</u>	<u>Consultants Network Support</u>
\$1,025,000	\$83,000	\$25,000

A consolidated campaign will be undertaken for the next five years to reach the \$3.3 million goal. Unless gifts are specifically designated for a particular purpose or with specific restrictions, further moneys received during this 5-year campaign will be allocated as follows:

75% for PCCCA Support and 25% for the Consultants Network account, until the total balance of those two accounts equals \$800,000. After this point, 100% would go to the National Position endowment account.

This is an important time in the life of Presbyterian camps and conference centers and we hope that you will do your part to support the future of these ministries.
